PAL BROWN DEFEATS HYLAND
THE OLD TIME STYLE FIGHTER

(BY JOE PRICE.)
Calgary, Oct. 15.—Amidst a silence which could almost be heard, Tommy Burns raised the right hand of "Pal" Brown above his head, thus declaring him the victor over "Fighting Dick" Hyland at the close of a fifteen round mill which will always be remembered by those present as the hardest fought one ever held in Alberta. The two boxers advanced to the centre of the ring after the gong at the end of the fifteen rounds with anxious looks on their faces. The bout had been nip and tuck all the way, and could have been called a draw in all fairness to both men. But Tommy Burns, following his custom of always declaring a winner when at all possible, lifted the arm of the victor. Pedmonium broke loose among the contingent of Brown supporters, while the Hyland crowd showed audible signs of disappointment. "Pal" Brown was as happy as a kid just out of school when the decision was given in his favor. A broad smile spread over his countenance and he turned a handspring as he went to his corner to be borne on the shoulders of his admirers to the dressing room.

Dick Hyland turned slowly and he was met by a crowd of dispirited back to his corner, where appointed supporters. Although he was defeated he was not disgraced. His game showing against the man to whom he conceded weight gained him a host of admirers who would go any distance to again see him box. The fourteenth round was the decider. Up to this time the bout could not have been called anything but a draw, with perhaps the margin of victory in favor of Hyland. But in this round Brown swung with a heavy right and dropped Hyland to his knees for the count of three, thus accomplishing more than Paeky McFarland had done in the two engagements between Hyland and the Stock Yard favorite. Hyland did not stay down long, but the knockdown was the deciding blow of the engagement. When he got up he was a little groggy, and was on the defensive until the end of the round.

But in the fifteenth Hyland came back strong and forced the bout. In this round Hyland fighting for the first time during showed his real form, which gained him the name of Fighting Dick. Brown rushed him at the start, hoping to finish him, but instead he was met by a volley of blows which forced him back to his corner, where he was given severe punishment. The fifteenth

round was clearly his property, but not by large enough margin to overcome the disadvantage of the disastrous fourteen.

As is usual when a real high class encounter is staged in Calgary, the crowd was very small—only about half as large as the crowd which watched the battle between Bayley and Allen last month. But those who did attend are unanimous in declaring it the best bout which has ever been held in Alberta. Every event on the programme was of the top notch variety, the two preliminaries being better than most of the main bouts of the past. The threatening weather was undoubtedly to blame for the small attendance. Fifteen minutes before the advertised time for starting the heavy clouds which had been blowing across the northern sky let loose a flurry of snow, the first of the season. As is well known, the arena is roofless, which makes it a rather uncomfortable place in case of a storm. Tommy Burns already has the architects figuring upon the cost of material for a covering, and hopes to have the arena covered by Thanksgiving Day, when the next bout will be staged.

Admission Too High.

The J. B. A. A. promoters of Victoria learned a bitter lesson on the occasion of the opening boxing and wrestling tournament of the season, for which they set the price of admission so high that many intending patrons turned away in disgust from the wicket. The promoters don't know yet how they stand, but it is very unlikely that they cleared expenses. For the next tournament, which is planned to be held in about a month's time, the prices will range lower. The decrease, according to one of the officials, is enough to make all the difference between a full house and a corporal's guard.

Signs with Boston.

Boston, Oct. 15.—George T. Stallings, who has been selected by President Gaffney of the Cubs to manage the team next season and the four succeeding ones, is said to have a contract with the Boston club that calls for a salary of approximately \$50,000 for the five years. Stallings is to have absolute control. That was one of the conditions under which he agreed to come to the Hub and manage affairs.
