ENGLISH SONS SOCIAL DANCE

Proved an Interesting and Unique Event—Many Pretty Baskets.

The box social held under the auspices of the Sons of England in the St. Andrew's Hall last night was very enjoyable although a larger crowd could easily have been handled. The night had just enough coolness to make dancing enjoyable without any signs of overwork and the floor of the big hall was in the best of condition. Draped around the walls were the flags of England and Canada and conspicuous among these were the crosses of St. George, the emblems of England and the society. Delightful music was provided by Harvey's four-piece orchestra for the 22 numbers on the dance program.

The feature of the evening was the sale of the baskets which took place after the supper waltz. The display had been brought into the hall several dances before the auction and the many artistic and unique boxes drew the admiring attention of all the dancers. They took many different forms although most of them were highly decorated and elaborate baskets. There were cradles, coal scuttles and other odd looking affairs. George Leek acted as auctioneer and starting with the three prize winners went down the line of boxes, many of which drew big prices as the limit was withdrawn. The highest price was brought by a basket which was sold and resold and totalled \$15.75. A total of \$130 was realized from the sale. The judges of the baskets were S. M. Newton, H. F. Pullen and F. J. Fuller and the prizes were won by Mrs. E. A. Woods (first), Mrs. Kemp (second) and Mrs. Geo. Leek (third).

John Myhill-Jones was Master of Ceremonies and the Committee in charge was composed of J. Day Bell, E. J. Cobb and Richard Howe. George Waddell arranged a very effective spotlight for the moonlight waltz. It was well after 2 o'clock when the last waltz was played and the dancers dispersed.

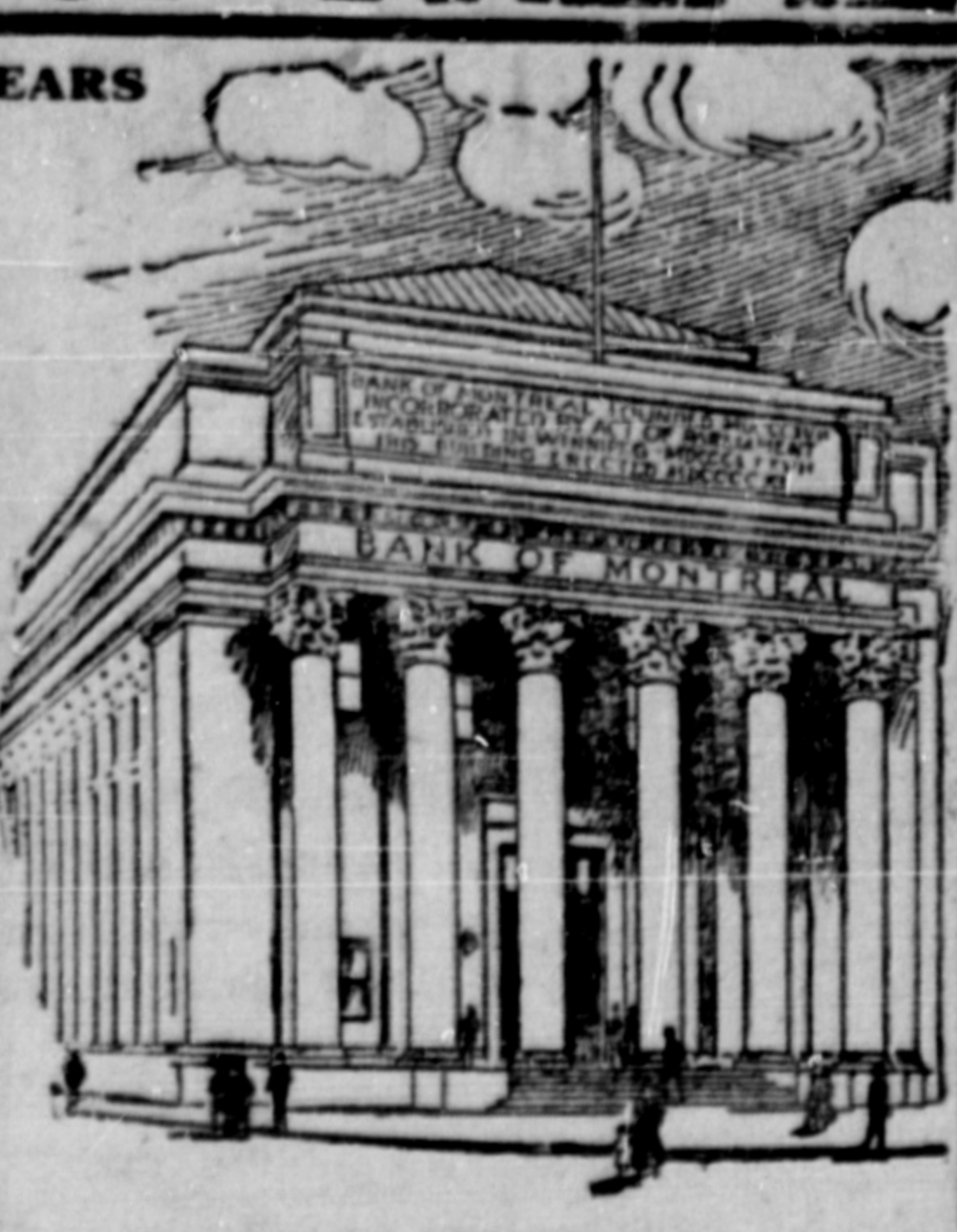
